Anthony Robles

Anthony Robles is a three-time all-American wrestler who won the 2010-11 NCAA individual wrestling championship in the 125-pound weight class despite being born with only one leg. A graduate of Arizona State University with a degree in business communication, he was also awarded the 2011 NCAA "Best Wrestler of the National Tournament" award.

In 2011, Robles was the recipient of the "Jimmy V Perseverance Award" at the ESPN ESPYs



and also received the NFL "Hispanic Heritage Leadership Award." Robles is a Nike athlete, the first signed to an agreement after having retired from active participation in a sport. He is currently ESPN's NCAA wrestling analyst and expert, and is the wrestling analyst for the Pac-12 Network as well. He was inducted to the National Wrestling Hall of Fame in 2012 and is the author of *Unstoppable: From Underdog to Undefeated: How I Became a Champion.* In 2013, President Obama appointed Robles as a member of the President's Council on Fitness, Sports & Nutrition. Additionally, Robles was a member of the Presidential Delegation to the 2014 Sochi Paralympic Games.

Robles lives in Chandler, Arizona. The script for a feature film chronicling his life story has been completed; the film is currently in preproduction.
